
### A Special Message: Keeping You, But Not History, at a Distance

Firehouse No. 5 located at 1310 E Adams was the city's first all black firehouse. The Society provided Central 3 Community First Project Inc. a \$1,000 grant for a sign describing the firehouse's history and role in the 1908 race riot. Eva Monroe ran the Lincoln Colored Home for black orphans and elderly for over 30 years. Mary Lawrence helped fundraise for the cur-

rent building at 427 S. 12th St. which was build in 1904. The Judge Taylor home at 12th and Cass became the Ambidexter Institute, which was an industrial school based on the Tuskegee Institute.

Kathryn Harris's interest in the sites started since she lives across from the firehouse. She used her librarian skills to research that building and the Lincoln Colored Home. Sue Massie's connection is through the work she did with the Judge Taylor home.

Kathryn and Sue emphasize the power of collaboration, awareness, and signage for the sites. The Society looks forward to their tour (hopefully) in the spring.

# Tony Leone (1950-2021)

Life member Tony Leone passed away in early February. He was a local author, historic preservationist and history enthusiast. Leone co-authored the book Springfield's Celebrated Horseshoe Sandwich. The Springfield Historic Sites Commission named him the 2011 Historic Preservationist of the Year. He was involved in the Roman Cultural Society in Springfield. Tony was a regular at Society programs. The Society had their holiday party at his beloved Pasfield House in 2016.


